The Undersigned acknowledges that by engaging in Grad Night activities, the Participant is to act in a reasonable manner at all times and to listen and follow the instructions of the Chaperones and Vendors. The Undersigned also acknowledge that by engaging in Grad Night, the Participant agrees not to engage in prohibited behaviors, including any acts of violence, unlawful drinking, smoking, vaping or use of drugs.

The Undersigned certify that the Participant is fully capable of participating in Grad Night. The Undersigned represent that the Participant is in good health and has not been advised by a physician to refrain from Grad Night activities. The Undersigned know of no reason, health-related or otherwise, why the Participant is not capable of participation in Grad Night activities including, but not limited to activities which require physical exertion such as running and dancing. The Undersigned accept full responsibility for any injuries or illnesses that the Participant may suffer during Grad Night activities, including, but not limited to, those resulting from any pre-existing medical condition.

THEREFORE, IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN GRAD NIGHT, THE UNDERSIGNED ASSUME ALL RISKS AND ACCEPT FULL RESPONSIBILITY SURROUNDING PARTICIPATION IN GRAD NIGHT, TRANSPORTATION RELATED TO GRAD NIGHT, AND ANY ACTIVITIES UNDERTAKEN AS AN ADJUNCT THERETO, WHICH RISKS AND RESPONSIBILITY INCLUDE BODILY INJURY, DEATH, OR LOSS OF OR DAMAGE TO PERSONAL PROPERTY AND EXPENSES AS A RESULT OF THOSE INHERENT RISKS AND DANGERS IDENTIFIED HEREIN AND THOSE INHERENT RISKS AND DANGERS NOT SPECIFICALLY IDENTIFIED, OR AS A RESULT OF THE PARTICIPANT'S NEGLIGENCE IN PARTICIPATING IN GRAD NIGHT, AND THE UNDERSIGNED SHALL NOT HOLD OR ATTEMPT TO HOLD THE VENDORS RESPONSIBLE THEREFORE.
